

EXCHANGE TRADED CONCEPTS

PRIVACY POLICY NOTICE

At Exchange Traded Concepts, LLC (“Exchange Traded Concepts”) our clients’ privacy is a priority. Client information is shared only in limited ways and for specific purposes. Exchange Traded Concepts collects personal information to open new account(s), to process transactions and to help us provide a better level of service. We do not sell client information to anyone. We protect the security and confidentiality of the personal information we collect.

This notice describes the privacy policy followed by Exchange Traded Concepts regarding: (i) how we treat the information we receive about individuals who apply for or obtain our products and services; and (ii) the third parties with whom we may share this information.

Information Exchange Traded Concepts Collects

Depending on the nature of your relationship with us, and in order to provide you with individualized service, Exchange Traded Concepts must obtain certain non-public information from you. We collect personal information about you that you provide on account applications or other forms (such as your address and social security number/tax ID) as well as information about your account transactions with us (such as purchases, sales and account balances). We may also collect such information through your account inquiries by mail, email or telephone. In all cases, we collect only personal financial information that is either required or necessary to provide appropriate financial services to you.

Sharing of Information

We do not disclose any non-public personal information about you to anyone, except as permitted by law, in which case we may disclose any of the non-public personal information that we collect. Specifically, so that we may continue to offer you products and services that best meet your investing needs, and to effect transactions that you request or authorize, we may disclose the information we collect, as described above, to companies that perform administrative or marketing services on our behalf (such as transfer agents, or printers and mailers that assist us in the distribution of investor or client materials (collectively, “Service Providers”). Service Providers will use this information only for the services for which we hired them and are not permitted to use or share this information for any other purpose. The ability of Service Providers to protect the personal financial information of our investors and clients is an important consideration in our relationship with them.

Information concerning Former Clients

If a client decides to close their account, Exchange Traded Concepts will continue to adhere to the privacy policies and practices described in this notice.

Protecting Confidentiality and Security

Exchange Traded Concepts treats non-public personal information in a confidential manner. Our Supervised Persons are required to protect the confidentiality of all non-public personal information. Exchange Traded Concepts restricts access to non-public personal information to Supervised Persons who need to have access in order to service client accounts. Supervised Persons are subject to disciplinary action if they do not comply with our policies. We maintain physical, electronic and procedural safeguards to protect your non-public personal information.
